- The Chair highlighted some of the results of the evaluations and the changes implemented on suggestions given. ## Communication Strategy

M. Jacobson provided an overview of the communications strategy to promote awareness regarding the public hearings.

## Public Hearings

L. Perra provided information to members regarding changes to their assigned hearings.

Presentation: The Impact of Electoral System Reform - Elizabeth McLeay
Questions on the following items were raised:

- Was an open list model considered?
- Did voter turnout increase with change to MMP system?
- How well did voters deal with the changed electoral system?
- Where do ministers come from: list or constituency?
- What happens if party wins more seats than popular vote?
- Basis of Maori votes

The presentation concluded and Assembly members moved into discussion groups.
Plenary Session: Round-up Question Period - K. Carty, D. Farrell, E. McLeay, C. Sharman

Some of the issues raised included:

- Limitations on number of seats, i.e. thresholds
- Does electoral system motivate voters?
- Effectiveness of government during period of change, coalition building
- Reaction to larger district sizes
- Policy shifts under MMP
- Impact of a closed versus open list
- How do parties differentiate themselves in a coalition?
- Why do people split their vote in a two-vote model?
- Why do the Irish support STV?
- Need for reserved seats in a PR model?
- Impact of reserved seats in New Zealand
- Impact of electoral systems on the quality of politicians
- Challenges faced in the New Zealand implementation
