

PRESENTATION SUMMARY

DUNCAN PUBLIC HEARING DATED
8 JUNE 2004 AT THE TRAVELODGE
SILVER BRIDGE

DESCRIPTION OF PRESENTATION

To curb political power, I propose therefore that we have a bi-cameral arrangement, composed of:

- a) a legislative assembly of local representative who shall be non-political;
- b) an Executive Council, elected from the province as a whole.

KEY THEMES

David Tanner told the assembly that he had worked in the provincial government for 30 years and was very dissatisfied with the violent swings in government policy that occurred during this time. He explained that he wanted to improve the quality of local representation through a bicameral legislature, where voters would vote both for a party leader to sit on an Executive Council and a non-partisan local representative. The Executive Council would be made up of 40 members, which each party being allocated seats on the Council in proportion to its share of the vote for each party's leader. Party leaders would select any additional members to sit with them on the Council. The party leader with the largest team in the Council would form the government. The legislative assembly would be formed as it is at present although MLAs would not have any party affiliations. While the Executive Council would have the power to propose legislation, only the Legislative Assembly would have the power to pass legislation.

RECOMMENDATIONS

David Tanner recommended the creation of a non-partisan Legislative Assembly, elected using FPP, and a proportionally elected 40 member Executive Council.

Quote: "This proposal would, it is hoped, allow for better local representation than occurs at present; and would also ameliorate the swings of violent political change that have been taking place until now."
